TO OUR PROFESSIONAL COSTS & DISBURSEMENTS, in respect of acting for the Morobe Provincial Government, in the Wafi-Golpu Legal Proceedings note above, from October 2018 until 15th July 2019, more or less summarized as follows:

1. October 2018

- with emphatic reply from PM O'Neill, undertaking not to enter such an agreement, without proper consultation and dialogue with the host Province of the Mine, namely Morobe Provincial Government.
- Provided backup support for Governor during the Parliamentary Session, leading into APEC week;
